Consequently, 03 applicants submitted their proposals for the subject tender which were received and opened on 19-02-2021. Notified Procurement Committee evaluated the Technical Proposals in accordance with Rule No. 32 of Punjab Procurement Rules, 2014. As per Technical Proposal Evaluation Report, 3 firms were declared Technically Responsive according to their submitted profile. The Technical Proposals Evaluation Report was uploaded on official website of PMU & P&SHD and was informed to all the applicants.
- Foregoing in view, Project Management Unit (PMU) received the grievance from an applicant against the Financial bid opening meeting dated 15-03-2021 related to the bid form typing matter of the subject tender. The grievances of the applicant is attached at Annex-B. In accordance with Rule-67 of PPR-2014 the Grievance Committee after examination of grievances, scrutiny of record, hearing the representative of each aggrieved applicant / firm and due deliberation and discussion, decided upon the grievances of the bidders.
