PANDEMIC BRINGS PMU TO PROMINENCE

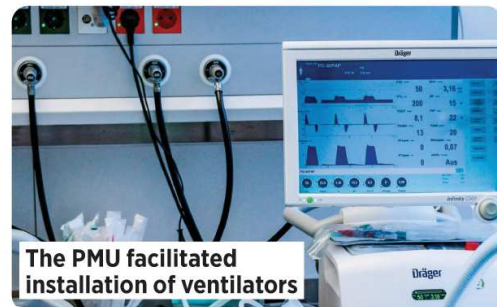

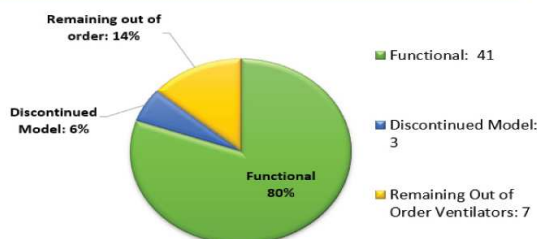

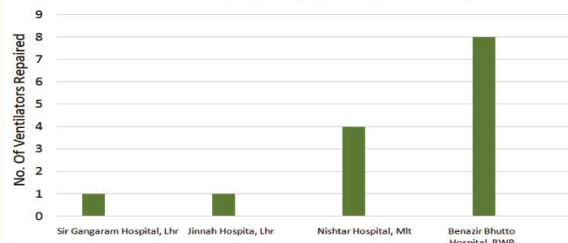

SUMMARY OF COMPLAINTS REGARDING FAULTS OF BIO-MEDICAL EQUIPMENT

Since 17th November, 2017 to date, Total 8,704 complaints have been registered on Computerized Maintenance and Management System (CMMS) through universal helpline 1454 out of which 6,700 complaints are resolved, 1,310 are in Progress due to spare parts unavailability and remaining are in hand.

BERC maintained and updated the details of more than 8,972 In-Warranty Bio-medical equipment in CMMS

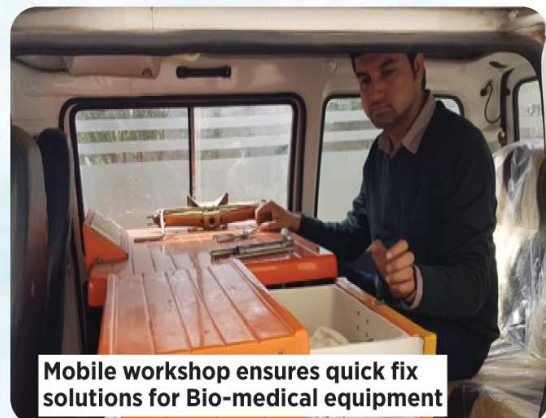
