Project Management Unit, Primary & Secondary Healthcare Department invited bids for Procurement of Biomedical & Non-Biomedical Devices and Furniture Items for Secondary Healthcare Facilities of Punjab. Tender Notice was published vide IPL # 8433 and the bidding document was uploaded on the websites of the P&SH Department and PPRA. The date for pre-bid meeting and submission of clarifications was affixed on 26.08.2022 and the date for submission and opening of bids was affixed on 07-09-2022.
